Delegates who successfully complete this CQI and IRCA Certified ISO 50001 Lead Auditor (EnMS) Training course (within five years prior to applying to become a certified auditor) will satisfy the training requirements for initial certification as an IRCA EnMS Auditor.

COURSE VENUE

b) Management System Audit

Knowledge of management system audit through successful completion of a CQI-IRCA Certified (or acceptable alternative) Lead Auditor Training Course in another discipline.

c) ISO 50001

An understanding of the requirements of ISO 50001 and the commonly used energy management terms and definitions, as given in ISO 50000, which may be gained by completing CQI and IRCA Certified FD130 ISO 50001 Foundation (EnMS).

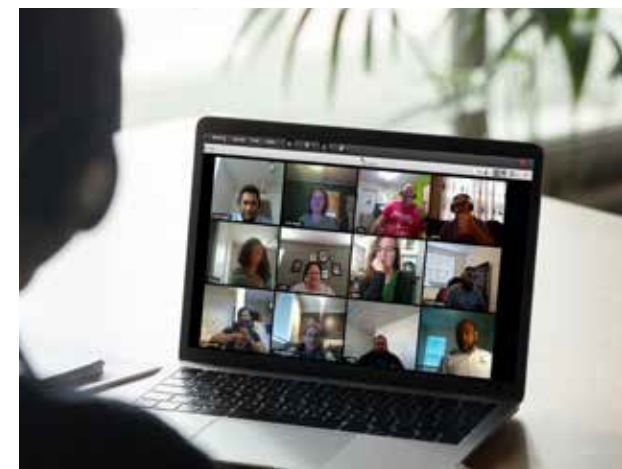
