


BENEFITS

ADDITIONAL INFORMATION

Those who have already attended a 1 day Training Module on Annex SL Framework (CQI-IRCA PT 211) or any of the 2 day combined auditor transition training on ISO 9001:2015 (CQI-IRCA Certified (PT 233) or on ISO 14001:2015 (CQI-IRCA Certified PT 215) can attend only this module and still qualify for certification as Auditor transition to ISO 45001:2018. All others shall attend at least a 1 day Annex SL Module (CQI-IRCA PT 211), followed by this module.
