ISO 45001 is an international Occupational Health and Safety Management Systems (OHMS) standard. It enables an organization to have control over, and knowledge of, all relevant hazards resulting from normal operations and abnormal situations, and improve its performance.

OUR CERTIFICATION PROCESS

Key steps in our certification process are:

- **Definition** of certification **scope**.
- Pre-audit (optional): gap analysis and diagnosis of your current position against standard.
- Certification audit performed in 2 stages :
 - Stage 1. Readiness review performed to verify that the organization is ready for certification
 - **Stage 2.** Evaluation of implementation, including the effectiveness, of the management system of the organization
- STAGE 1 PRE-AUDIT (OPTIONAL)
- A certificate valid for 3 years is issued upon satisfactory results of stage 2 audit.
- **Surveillance audits** to verify that the management system continues to fulfill the requirements of the standard and monitor the continual improvement.
- **Re-certification** after 3 years to confirm the continued conformance and effectiveness of the management system as a whole.

1 WHY SHOULD MY ORGANIZATION IMPLEMENT ISO 45001?

Automotive companies are responsible for the health and safety of their employees to create a safe and healthy work environment. From the suppliers of parts, until the dealership and shops providing car repair and maintenance. The entire automotive value chain is concerned. At each stage of the chain, it is an absolute to help workers in facilitating operations thanks to ergonomically oriented working stations, sequence of operations reducing walking distance or carrier systems for heavy parts. Health & Safety issues can also come from lack of attention such as smartphones "distraction", or "forgetting" to wear personal protection equipment. Also, industrial places are not the only ones to be considered. At R&D Centers, technician and engineers are also a population working under high dose of stress and pressure potentially causing new damages like "Burn Out".
