BUREAU VERITAS is committed to communicate this policy to all employees within the organization and to other interested parties. The policy shall be subject to periodical review and update to ensure its suitability, relevance and appropriateness.

2.2 Certification Policy

To deny certification to candidates who lack understanding in any subject area in which Riggers, in their particular field, are expected to have a certain level of competence.

2.3 Disciplinary Policy

BUREAU VERITAS with its certification scheme committee is responsible for establishing and implementing standards and policies of Ethics and Discipline and for disciplinary action. Grounds for revocation of certification status shall include, but not be limited to, the following:

- Period of certification exceeded without renewal.
- Evidence of falsification of any information on any documents submitted to BUREAU VERITAS.
- Evidence of culpability in an accident during certification period.
- Evidence of non-compliance with medical requirements.
- Evidence of non-compliance with the Code of Ethics.
- BUREAU VERITAS has established policies and procedures to address alleged violations of the Code of Ethics fairly and consistently.

2.4 Eligibility, Physical Qualification, Rights & Duties

Eligibility

To be eligible for certification, candidates must:

- Be at least 18 years of age.
- Meet medical requirements.
- Comply with BUREAU VERITAS Policy (Examination Policy)
- Comply with BUREAU VERITAS code of ethics & Substance abuse policy.
- Pass Written Examination
- Pass Practical Examination.

Physical Qualification and Examination of Operators

Bureau Veritas DO NOT conduct physical examination for the candidates, as this is the responsibility of candidate's employer, see (refer clause 1.5 the candidate abilities) but in the interest of public safety, the examiner will make sure that the candidate does not have any physical, mental, or organic defect of such a nature as to affect the operator's ability to operate a crane safely.

- The candidate must attest to his agreement to this requirement in his applications.

- Means of compliance with BUREAU VERITAS of which the physical requirements include the following but are not limited to:
 1. Has no loss of a foot , a leg , a hand , or an arm
 2. Has no impairment of the use of a foot, a leg, a hand, fingers, or an arm, and any other bodily physical defect or limitation, which is likely to interfere with his ability to operate and control a crane in safe manner.
- BUREAU VERITAS will not accept any candidate who does not comply with 1 & 2 requirements.

Candidate Rights and Duties

➤ Candidate Rights

- Information supplied by an individual or employer is for the confidential use of BUREAU VERITAS and will not be disclosed without a written permission of the individual or employer concerned.
- All Certified Persons will receive certification and an **ID** card.
- The candidate not passing the first written or practical exam or both has the right to re-sit for 50% of exam fees for one time only, then if he fails his re-sit exam, he will require to re-register for re-attendance from the beginning with full charge.
- For an applicant of special needs has opportunity to declare, within reason, a request for accommodation.

➤ Candidate Duties

- A candidate must attest to his agreement in his application that his medical profession has found him physically qualified to act according the training mentioned above according to the relevant standard.
- He further agrees to the following Conditions:
 - a. To comply with the relevant provisions of the certification requirements and to supply any information needed for the assessment.
 - b. To comply with Bureau Veritas examination policy in maintaining the integrity and security of the examination process and be committed and not to release confidential examination materials or participate in fraudulent test- taking practices. Any irregular or improper behavior in examinations that is observed or uncovered by other means will be considered a subversion of the certification process and will constitute grounds for invalidation of a candidate's examination. In addition, Bureau Veritas may at its discretion suspend or revoke a candidate's certification, exclude candidates from future examinations. ((Examples of irregular or improper behavior include giving or obtaining information or aid, looking at the test material of others, removing examination materials from the test center, bringing unauthorized items,

including watches or electronic devices (e.g., Laptops, cell phones, etc.), into the examination))

- c. Failing to comply with time limits or instructions, talking, or other disruptive behavior. Test administrators may intervene to stop any of the foregoing and inform the certification Scheme Committee.
- d. To make claims regarding certification only with respect to the scope for which certification has been granted.
- e. Not to use the certification in such a manner as to bring the certification body into disrepute, and not to make any statement regarding the certification which the certification body may consider misleading or unauthorized.
- f. To discontinue the use of all claims to certification that contains any reference to the certification body or certification upon suspension or withdrawal of certification, and to return any certificates issued by the certification body, and
- g. Not to use the certificate in a misleading manner.
- h. To abide by the conditions of certification and agree to inform the certifier of any changes affecting the status of the certification.
- i. To mention the name of any known person in **BUREAU VERITAS** from the beginning to prevent any conflict of interest or any problem taking place.

3. CERTIFICATION SCOPE AND OBJECTIVES

3.1 SCOPE

The riggers certification program has been developed to include all the processes and tasks needed to evaluate knowledge and skills for individuals who are seeking certification for riggers.

3.2 OBJECTIVES

The Riggers Certification Program was developed to identify those individuals with the professional knowledge and skills worthy of being designated as a Certified Rigger. Therefore, the Riggers Certification Program is intended to accomplish the following objectives:

- Identify riggers who meet or exceed the minimum criteria for certification.
- Stimulate the improvement of rigging and establish it as a certifiable profession.
- Enhance the practice and profession of rigging through validated and reliable certification instruments.
- Directly promote rigger competency and a safer work environment.
- Organize and implement a comprehensive program for the qualification of riggers.
- Promote the development of knowledge and skills of those interested in the rigging profession.
- Provide technical assistance to agencies having regulatory authority applicable to testing and certification of riggers.

4. JOB AND TASK DESCRIPTION

To ensure this Person is responsible for attaching and detaching the load to and from the crane hook block, and for correct selection and use of lifting accessories and responsible for correctly directing the crane driver to ensure safe movement of the crane and load.

5. CANDIDATE EXPERIENCE AND REQUIRED COMPETENCE

Bureau Veritas riggers certification exams are designed for riggers who are trained and who currently deployed in Lifting Equipment operation. The candidate is a rigger with appropriate practical and theoretical knowledge and experience for safe rigging and slinging operation of lifting equipment.

6. CANDIDATE ABILITIES

The Client or the employment company is responsible to ensure that the certified rigger should meet the required physical requirements throughout their certification periods and attest to their agreement as per requirement within their applications.

To qualify as a rigger, the person should be:

- Be medically and physically fit (have a good eye sight, hearing).
- Have been trained in the safe use of lifting equipment.
- Capable of reading and understanding the English language sufficient for the fulfillment of their function in a safe manner;
- Ability to select and use the lifting tackles as per load configuration;
- To be able to provide necessary clear hand signals for crane operators as per standard signals within the training material booklet.
- To locate a load in away, to ensure safety of load and consideration for working personnel;
- To understand his companies' rules and regulations, color coding and around it the reasons Certification of lifting tackle is required;
- To be able to communicate with radio where the crane operator is out of range.

7. PREREQUISITES

The Candidate who are based in the UAE must submit the following along with duly filled application for certification:

- Passport copy
- Valid residence visa copy
- Labor card copy
- Colored photograph (not older than six months)
- Proof of training (if relevant)
- Evidence of working experience.

Note: Candidates from other countries shall submit valid identification document issued by the relevant governments.

8. CODE OF CONDUCT

8.1 CODE OF ETHICS FOR CERTIFIED RIGGER

Certified Rigger must comply with **Bureau Veritas** Code of Ethics during their certification, as set below:

- During my occupation, I will conduct myself in such a manner:
 - a. So as to be free of bias with regard to religion, ethnicity, gender, age, national origin, and disability.
 - b. So as to place the safety and welfare of others associated with the lifting operation above all other considerations.
 - c. So as to protect and preserve nearby general public property and the environment.
- Furthermore, in connection with the lifting operation work and in my dealings with **Bureau Veritas**, I will:
 - a. Assure management and appropriate attending personnel of my awareness promptly, if I have any safety concerns relating to the work that I am performing or with which I am involved;
 - b. Not knowingly violate any safety-related regulations, warnings, or instructions set forth by OSHA, recognized safety standards, prevailing jurisdictions, of manufacturers equipment;
 - c. Not mislead, misrepresent or knowingly deceive others concerning my experience or the capabilities of myself or the equipment I am operating or with which I am controlling.
- In addition, in my dealing with **Bureau Veritas**, I will:
 - a. Provide accurate and complete information and abide by **Bureau Veritas**, its policies and procedures, including this Code of Ethics, as they may be updated from time to time.
 - b. Cooperate fully and completely with any administrative inquiries of investigations by **Bureau Veritas**.
 - c. Not misrepresent or misuse any **Bureau Veritas** card, or acronyms and logos, or any registered trademark or other intellectual property of **Bureau Veritas**.

It is the responsibility of the certifying organization to have the candidate understands the code of Ethics.

8.2 SUBSTANCE ABUSE POLICY

It is the policy of Bureau Veritas that Signalman shall not use prescribed or over-the-counter substances that would impair their ability to perform Rigging activities safely. This includes illegal drugs, controlled substances (including trace amounts), look-alike drugs, designer drugs, or any other substance that may have an effect on the human body of being a narcotic, depressant, stimulant, or hallucinogen.

An exception to this rule is that a rigger may use such a substance or drug if it is prescribed by a licensed medical practitioner who is familiar with the rigger's medical history and all assigned duties. If this being the case, then that rigger before registration shall support his medical condition by means of a written statement and/or certificate prescribed by the said licensed

medical practitioner that the prescribed substance will not adversely affect the rigger's ability to perform the rigging of lifting equipment task in a safe manner

9. CERTIFICATION REQUIREMENT OF RIGGER

9.1. Criteria for Initial Certification Process and Recertification Process

➤ Submission of Application

- Candidate must complete and sign the **candidate Registration Form**, Which includes an affidavit that a medical professional has found him physically qualified to carry out the objective of the technical requirement according to the relevant standard and must be aged over 18.
- The candidate also must complete and sign **Certification Assessment Application form** to enable the certifying company issuing the operator passport ID for the certified person.
- The **Bureau Veritas** shall require that all candidates who are based in UAE must submit the following documents along with duly filled application for certification :
 - a. Passport copy.
 - b. Valid residence visa copy.
 - c. Labor card copy.
 - d. Colored Photograph (not older than six months).
 - e. Proof of training (if relevant).
 - f. Evidence of working experience.

➤ Recertification Process

- Bureau Veritas will remind the certified personnel of his certification expiration 2 months prior to the expiration date.
- If the personnel wants to re-certify, application form will be sent to him to be filled and submit it back.
- All candidates must complete all recertification requirements prior to the certification's expiration date. This includes:
 - a. **Passing the recertification written and practical examination**
 - b. **Continuing to meet Occupational Health Card requirements**
 - c. **Have valid driving license from the relevant authority where applicable**
 - d. **Compliance with Substance Abuse policy**
 - e. **Compliance with the Code of Ethics**
- Recertification Written/Oral and practical examinations must be taken up to one month prior to the certification's expiration date.
- Candidates who are not certified in all specialties may add a new specialty at the same time as they take their Recertification Examination and he must fill an application form to specify the required specialty.

9.2 Assessment Method and Mechanism for Initial Certification and Recertification

- The certified rigger should carry out the two levels of Rigger level I & Rigger level II.
- Rigger Assessment Method and Mechanism will consist of two stages for the two level of Rigger I & Rigger II together:
 - a. Written Examination for the two levels together.
 - b. Practical Examination for both levels at the Client site.
- The candidate must register for both stages.
- A candidate must pass the two stages Written and Practical Examination to be certified for a one-year period.

9.2.1 Written Examination

- Consists of Rigger Level I and Rigger Level II Examination
 - Rigger Level I Examination:
 - a. It tests the areas relating to rigging such as the scope of the rigging activity, identifying rigging components, technical knowledge, inspection and execution of rigging activities.
 - b. It consists of 30 multiple choice questions
 - Rigger Level II Examination:
 - a. It tests the areas relating to rigging such as the scope of rigging activity, planning the rigging activity, selection of rigging components, inspection and execution of rigging activities
 - b. It consists of 40 multiple choice questions
- Written examination will be conducted at the Client premises, as feasible
- If the client does not have adequate premises to conduct the examination, **Bureau Veritas** will arrange for it at its premises.
- Minimum passing score is 80%.

9.2.2 Practical Examination

a. Rigger Level I

- The practical examination demonstrates a candidate's basic rigging competency that the can perform simple, repetitive rigging tasks when the load weight, center of gravity, the rigging, and rigging configuration are provided or known by the rigger through experience or on-the-job training prior to the rigging activities.
- Level I rigger should be able to demonstrate or have knowledge of how to:
 - Inspect rigging before use.
 - Identify and attach rigging with basic knowledge of hitch configurations, capacities, and basic knots.
 - Recognize associated hazards.
 - Signal Operations.
 - Use various types of rigging equipment and basic hitches and their applications.

- Rigger level I practical examination consists of four tasks
 - Pre-use rigging inspection
 - Rigging hitches
 - Rigging connections
 - Basic knots

b. Rigger Level II

- The practical examination demonstrates a candidate’s competency in rigging a load for a level lift and for rotating a load in addition to knowing and demonstrating rigger level I knowledge and skilled. They can select rigging components and procedures based on rigging capacity, Unsupervised.
- Level II Rigger should be able to:
 - Estimate load weight and center of gravity.
 - Identify lift points.
 - Determine and select rigging based on loading.
 - Perform pre-use inspection of rigging and lift points.
 - Understand periodic inspection criteria.
 - Identify and attach rigging with knowledge of hitch configurations and load angle factors, rigging capacities and load integrity.
 - Understand load dynamics and associated hazards.
 - Have a working knowledge of hoisting equipment, winches, jacks, industrial rollers and similar equipment if applicable.
- Rigger level II practical examination consists of Two tasks:
 1. Level lift
 2. Rigging frame rotation
- Practical examination will be conducted at the client site which is oral and practical.
- The examiner’s task is primarily to record the performance of the candidates.
- Scoring criteria will be set by the examiner.
- Minimum passing score is 75%.

9.2.3 Combining Certification requirements

➤ **Written/Oral**

- Rigger Level I exam maybe administered separately if the candidate would like to be certified only for level I.
- Rigger level I and rigger level II exams maybe administered separately or combined if the candidate would like to be certified for both levels

➤ **Practical**

- Once a practical examination starts for any certification area, it shall be finished prior starting other practical examination in other areas.
- Examiners are not allowed to combine the performance requirement of different specialties into one specialty

9.3 Time Examination and Order

- Candidates may take their written and practical examination in any order.
- In the normal cases, the examination time will be as following:
 - Written Examination: 1 hour
 - Practical Examination: 1 hour / Candidate
- In other cases, Time examination maybe extended by the examiner based on other variables and/or language barriers.

9.4 Decision Making Process

- After examination is done, the examiner will collect examination sheets, put them in a file, seal it and take them for scoring
- The scoring will be done as the criteria set by the certification department at **Bureau Veritas**, the minimum passing score for written examination is 80% and for practical is 75%.
- All candidates must pass both examination, written and practical.
- The scoring results will be passed to the decision maker who will make his decision based on the examination score, complying with all requirements, and completion of the certification fees.
- If all requirements are met, the candidate will be deemed as competent. A certificate and ID card will be issued.

9.5 Issuance of Certificate and ID card

- Competency certificate will be issued by **Bureau Veritas**, signed by the authorized signatory.
- ID card will be issued by **Bureau Veritas** for each certified person.
- Certificate will include at least, but not limited to the photo of the certified personnel, unique identification number for tracking, Category of equipment that the individual is certified to operate, issue date, expiry date and validity in addition to other contents as required by ISO 17024 standard.
- ID Cards will include the sentence “**This is not a driving license**”.
- All certified personnel should keep their original card with them all the time for review and checking from the relevant authorities during inspection.

9.6 Certification Time Frame

- All Certificates and certification ID cards will be valid for 1 year.

9.7 Re-Sit Examination for initial Examination and Re-examination

Normally, the candidate must pass both written and practical examination to be competent but if:

- The candidate have passed the written examination but failed in the practical or vice versa then, re-sit examination will be conducted.
- The re-sit examination will be scheduled with **Bureau Veritas** certification department.
- The fee of the re-sit examination will be 50% of the original certification fee.
- If the candidate fails in either one or both written or practical exam twice (Two times in a row), he will not take any further assessment until he undertakes a relevant training.

9.8 Training Requirement

Candidates who fail in either one or both written or practical exam twice (Two times in row) will not take any further assessment until they undertake a relevant training. The training must be as following:

For rigger level I: 1 days, 5-7 hrs.

For rigger level II: 1 day, 5-7 hrs.

9.9 Unsafe Act

- If at any time during the pre-Test period or during the test, candidates commit an unsafe act, examiners must disqualify candidates from continuing with the test if any of the unsafe acts present include but are not limited to the following:
 - a. Incorrect performance and unclear hand signals while moving a suspended loads.
 - b. Not conducting pre-inspection of lifting tackles before using them in service.
 - c. Uncontrolled or reckless operation.
 - d. Failure to respond to a stop signal.
 - e. Failure to ensure that the crane boom is positioned above the load center of gravity.
 - f. Contracting an obstruction with the crane boom or load by using the wrong hand signal.
 - g. Any action that could endanger personnel or equipment at the test site.
- The examiner has the authority to stop the test at any time for reasons of safety. Examiners are responsible for informing Public Health and Safety Department in that case by either emails letter or fax, records will be kept.
- If the candidate is disqualified due to an unsafe act, the case will be reviewed by the relevant authority, and candidate will be notified with the department decision of the eligibility for rescheduling the practical exam or otherwise.

9.10 Weather Condition and Equipment Problems

- The examiner must use an anemometer to check the wind speed and then will record the weather conditions on the examination sheet.
- The examiner has the responsibility to determine if the weather conditions or equipment problems are such that a test needs to be suspended.
- If the test is interrupted due to weather conditions or equipment problems, the procedures for restarting is as follows:
 - a. Candidate will resume the test at the beginning of the task he was performing at the time of interruption.
 - b. Candidate resume the test on a different machine, he may start the entire test over from the beginning.
 - c. If the testing is delayed to a different day, the test will be restarted from the beginning.

9.11 Suspending, Withdrawing and or Changing scope or Level of Certification

- **Bureau Veritas** has established documented procedures for suspension or withdrawal of the certification, or reduction of the scope of certification.
 - Failure to resolve the issues that have resulted in the suspension, in a time established by **Bureau Veritas** shall result in withdrawal of the certification or reduction of the scope of the certification.
 - **Bureau Veritas** shall have enforceable arrangements with the certified person to ensure that, in the event of suspension of certification, the certified person refrains from further promotion of the certification while it is suspended.
 - **Bureau Veritas** shall have enforceable arrangements with the certified person to ensure that, in the event of withdrawal of certification, the certified person refrains from use of all references to a certified status.
